## EVENT INFORMATION AND RULES

- The Craft Fair will be held RAIN OR SHINE on Saturday, October 19th, 2024 from 11AM to 4PM at **Trinity Reformed Church, United Church of Christ ("Trinity"), located at 532 East Main Street, Collegeville, PA 19426**. Please enter the social hall via the ramp on the side of the church.
- Setup to begin no earlier than 9:30 and takedown after 4PM. All vendors are expected to vacate the building no later than 5PM. Vendors are expected to stay for the entirety of the event.
- Please do not leave anything behind. You are responsible for taking with you and discarding of all your trash, boxes, packing materials, print materials, etc. Booth space must be left clean when you leave.
- Trinity is an alcohol and drug free space. no illegal drugs or alcohol may be used, consumed, sold, or given out on the premises.
- Two vendors may share a space; however, each vendor will be required to pay the \$10 vendor fee. Please submit a registration for each vendor and not on the application that this is for a shared space and whom you are sharing with.
- NO REFUNDS will be given for any reason, unless Trinity cancels the event.
- If possible, PLEASE PROVIDE A PICTURE OF SAMPLE PRODUCTS for advertisement purposes. Pictures may be submitted with the application or sent via email to [events@collegeville.church](mailto:events@collegeville.church) after your application has been accepted.
